NOTICE INVITING TENDERS.

SEALED TENDERS ARE INVITED FROM THE INTERESTED PERSONS / SUPPLIERS/ CONTRACTORS /COMPANIES, AS PER WORK'S LIST ATTACHED UNDER SPPRA RULES 2010.

1. The intended participants can purchase the separate set of tenders on payment of tenders fee for each work **26-01-2015** at **1:00 Pm.**
2. The tenders shall be received back on date **27-01-2015**, upto **2:00 P.M.** and opened at **3:00 P.M** same day, in the presence of tender opening / evaluation committee and bidders or their authorized representatives who wish to be present.
3. Eligibility condition for intending participants are as under:-
 - i. Registration with Pakistan Engineering council in the relevant field of specialization of work and to the extent of tender amount of each work.
 - ii. Bio date of Engineering and technical staff working with firm.
 - iii. Documentary evidence of work executed / works in progress and certificate of satisfactory completion of works by the employers.
 - iv. List of works in progress indicating cost of each work and copy of letter of award of work.
 - v. List of machinery and equipment available with documentary evidence of its ownership certificate of Bank showing credit worthiness along with Bank Statement.
 - vi. Certificate of at-least two Highways Division showing the statement of works carried out satisfactory.
 - vii. Certificate of at-least two Highways Division showing the statement of works carried out satisfactory.
4. Registration with Income Tax Department (NTN Certificate) and copy of N.I.C.
5. Under Taking on Affidavit that firm is not involved in any litigation or abandoned any work in the department.
6. The bidders should submit earnest money as shown against each work in shape of call deposit prepared from the Scheduled bank in favour of the undersigned.
7. Affidavit to the effect that the Firm/ Contractor have not been black listed previously by any executed agency.
8. Affidavit with effect that all document / particulars / information furnished is true & correct.
9. In case of firm, list of partners/ partner ship Deed, giving full particulars of Director / Proprietors or other connected along-with Power of Attorney. In case of being sole proprietor such undertaking on affidavit be furnished.
10. In case of works costing below Rs.2.500 (M) the conditions @ S.No.3 will not be applicable.
11. The procuring agency may reject all or any bids subject to the relevant provisions of PPRA rules.
12. In case any tender remains un-responded the same shall be issued upto **19-02-2015** at **2:00 P.M.** and will be received back and opened on **20-02-2015** at **3:00 P.M.**
