- 10. The Tenderers who quoted the highest rate will be entitled to lift the waste papers and used Answer Books etc subject to approval of the Chairman.

The successful Tenderers will be required to lift the entire stock of the Waste Papers and Used Answer Books within 07 days from the date of receipt of job order or by such date as may be communicated to him officially failing which Bid Security will stand forfeited and work shall be assigned to other bidder as per rules.
