- a) Bidding will be conducted as **'Single Stage Two Envelope Procedure'** as per SPPRA (2010) rule 46(2) and will be opened to all eligible Bidders.
- b) The blank tender documents can be obtained from the office of Administrator Zakat Sindh, Karachi, 8th Floor, Fareed Chamber, Abdullah Haroon Road, Saddar Karachi w.e.f the date of publication up to 23.01.2015 on any working day.
- c) The tender documents for the works will be issued on submission of application and payment of tender fee, as mentioned above.
- d) The parties/firms/contractors will submit the followings.
 - i) Copy of CNIC of Proprietor or partners
 - ii) Copy of Proprietorship/Partnership Deed
 - iii) Copy of NTN Certificate and sales Tax.
 - iv) Copy of Registration with Sindh Revenue Board only for Item No. 1 & 2
 - v) Three (3) years Experience in relevant field
 - vi) Financial Turnover at least 3 years (Bank statement or Bank certificate).
 - vii) Undertaking/affidavit on stamp paper that the firm is not involved in any litigation / arbitration or has not abandoned any work or has never been black-listed in any department.

- The party must submit the bid security/earnest money in shape of pay order/call deposit in favor of "Administrator Zakat Sindh for provision of Hand Pump and Sewing Machine", with the bid documents. In case of non-submission of bid security/earnest money the tenders will be rejected. Earnest money will not be refunded unless the final decision is made.
