The bids can be submitted in the name of Additional Secretary Admin, Excise, Taxation & Narcotics Department, up to 22<sup>nd</sup> January 2014 at 11:00 a.m. and will be opened on the same day at 12:00 Noon before the Additional Secretary (Admin), Excise, Taxation & Narcotics Department/ Chairman Precurement Committee and intending bidders who choose to be present on the occasion. In case of a holiday by the Government, the tender will be opened on the next working day.

- 4. Quetations shall be in accordance with the specification as mentioned in Tender documents or equivalent or better
- 5. Prices shall be quoted in Pakistan Rupees and shall be inclusive of all applicable taxes and duties & should cover at various locations in Sindh, no conditional bid(s) will be accepted.
- 6. Only firms registered with Income Tax & Sales Tax Department are eligible to participate in the tender. Proof of registration with the Income Tax & Sales Tax Department shall be enclosed with the bid.
- 7. The validity period of the bid/offer shall be at least 30 days. The minimum delivery period shall be mentioned in the bid/offer.
