- 03 Eligibility: Valid Registration with tax authorities & Valid Dealership/ Stockist/ Supplier Certificates.
- 04 Method of Procurement: Single Stage Single Envelope.

### 05 Terms & Conditions.

#### a) Responsive Bidder is required to submit following documents with bid:

- (i) Valid Registration with tax authorities & Valid Manufacturing/ Dealership/ Stockist/ Supplier Certificates;
- (ii) Affidavit that firm has never been black listed;
- (iii) Inspection will be done at Suppliers' premises.


#### b) Under following conditions bid will be rejected:-

- (i) Conditional and telegraphic bids/ tenders;
- (ii) Bids not accompanied by bid security of required amount, Tender Form, and clocuments mentioned in para (a);
- (iii) Bids received after specified date and time.
- (iv) Firms black listed by any Department of Govt. of Sindh/ Govt. of Pakistan.

#### c) Bid validity Period: (90) days.

- d.) Bid Security amounting to 2% of Bid Price should be submitted along with the Bid in shape of Pay Order in favor of Accounts Officer, UCG Thar Project, issued by any scheduled Bank of Pakistan.
- e) The bid security will be forfeited to the Government, if the bidder withdraws his bid after opening and before the expiry of the bid validity period or fails to sign the contract if the bid is accepted.
- f) Amount of the tender is below Rs.1 Million.
- g) Delivery time will be 20 days starting after the date of receipt of supply order.
