SPECIFICATIONS:

- a) The adhesive on stickers should be permanent nature. The stickers shall be pasted from inside of the screen of the vehicle and it should be readable from outside.
- b) Stickers should be printed on a Polythene film which shall be 0.15 MM. and should in accordance of sample provided by Excise & Taxation Department.
- c) On the front side of stickers, two colours shall be printed. Each colour should be visible from outside.
- d) All specified colours of stickers should be florescent colour and should not fade at least for six month after pasting.
- e) The Sr. No. of stickers should also be readable from outside.
- f) On the back side, the strips should be only silicon coated, transparent paper. These of strips should be one on the other for easily release of sticker's complete instructions for pasting should also be on these strips.
- g) Stickers for non-commercial should be in Octagon shape.
- h) Stickers for commercial vehicles should be in oval Shape.
- i) Stickers for rickshaws (CRS) should be in triangular shape.

CONDITIONS:

- 1) The vendor should be registered with Income Tax, Sales Tax and Professional tax and produce all required valid certificates.
- 2) Original receipt of tender documents should be attached with tender documents duly sealed.
- 3) The Vendor / Bidder will have their own complete plant of printing and all other related job.
- 4) Samples of all kinds of stickers shall enclose with their tender as per details and specifications.
- 5) The Vendor / Bidder shall produce past experience proof regarding related job, if required.
