- 2- The Tender document will be issued to contractor on the submission of written request on letter head of the company. Tender fee may be paid in cash and received of the same will be attached with tender document. No tender document will be issued on opening date.
- 3- Valid PEC registration certificate is required in respected category.
- 4- 2 % of earnest money (CVR) in shape of pay order/bank draft in favour of Ghorabari shall be attached with tender. In case the date of opening is declared as public holiday by the government, the next official working day shall be deemed to the date for submission and opening of tenders of the same time as mentioned.
