- 7. The bidders are required to submit the above information, the signed evidence against minimum qualification criteria along with their bids. However joint Venture between two or more firms is allowed subject to compliance of conditions of stipulated rules of PEC.
- 8. If any fake documents are fund then the tender is liable to be rejected/ cancelled without any compensation and with penalty as per rules.
