The Earnest Money equal 2% of offered rates/amount of Open Rate items and Earnest Money of schedule items mentioned against each work in shape of pay order from any scheduled Bank in favour of **Keamari Zone, DMC(South), Karachi** must be enclosed with tender documents, otherwise the tender will be rejected.

4. The Contractors must mention their complete and correct present/postal address in tender documents and quote the rates both in-words and in-figures. Incomplete / Conditional tenders will be not accepted. In addition, the bidders must furnish the documentary evidence against each eligibility as well as minimum qualification criteria. Otherwise their tenders will be summarily rejected.
5. If any fake documents are found then the tender is liable to be rejected/cancelled without any compensation with penalty as per rules.
6. Canvassing in connection of tenders is strictly prohibited and tenders submitted by the contractors who are reported to be involved in canvassing will be liable for rejection.
