- Condition as per Tender notice No. DDLA/AH/MED/14-15/1 will remain valid. However Deputy Director Livestock / Animal Husbandry Ghotki reserve the right to extend date, time of bid, opening or receiving the bids and to purchase all or part of stores under the tender.
- 2. All firms whether registered with Industries Department, Government of Sindh shall be required to deposit earnest money equivalent to 2.5% of the value of their offer with their tender in the form of call deposit/pay order in favour of Deputy Director Livestock / Animal Husbandry Ghotki. In case of less deposit of earnest money the tender will not be entertained and treated as cancel.
- 3. The successful tenders shall have to deposit, security deposit as under:
 - i) Registered firms 2.5% of the value of contract.
 - ii) Un-Registered firms 12.5% of the value of contract.
- 4. Registered firms whose registration for current financial year has not been renewed by the due date of tender shall furnish 12.5% for security deposit.
 5. Any cutting/correction in hid forms:
- 5. Any cutting/correction in bid form will make the quotation/tender invalid.
- 6. The bidder shall mention validity of offer, terms of payment, voluntary period and schedule of delivery.
- 7. Deputy Director Livestock / Animal Husbandry Ghotki, reserves the right to obtain clar fication from any bidder, in respect of item quoted by him. The replies by the bidder will be recorded and will form part of bid document.
- 8. The rates quoted must have the validity upto the end of current financial year i.e. 30-C6-2015.
- 9. Supply order / contact will be issued subject to the availability of funds.
- 10. The payment shall be made / released to the firms against the supply of the items / consignment in full after inspection report ensuring that the items / consignment are according to the specification.
- 11. The contracting firms will be treated under the clause -12,13 & 14 of Sindh Procurement Manual 1991, PPRA Rules 2004 & SPPRA Rules 2010, accordingly, in case of failure in supp y of stores, it shall be optioned to purchase the stores else where without notice, on the account and the risk of the contract.
- 12. The evaluation will be based on the name specification and the Deputy Director, Livestock / Animal Husbandry Ghotki reserves the right to choose specification at his discretion.

- 13. The tenderer shall sign the below mentioned certificates while quoting their rates failing which the tender/offer is liable be considered NO RESPONSIVE.
- 14. The bid documents should be properly sealed and tender No. and date of opening may be indicated on the envelope.
 15. Price must be queted in D. I.
- 15. Price must be quoted in Pak currency per accounting unit.
- 16. Bid must be supported with relevant literature etc, and county of origin make, brand should be recorded on bids against the item.
- 17. The firms participating in the tender must be registered with SALES TAX DEPARTMENT and should mention their sale tax registration No. along with copy of registration certificate in case of offering the tender for instruments & equipments.
- 18. The medicines to be supplied should have the label "PROPERTY GOVERNMENT OF SINDH" written prominently.
- 19. Breakage/leakage during transport is the responsibility of supplier.
- 20. No medicines will be accepted with the expiry less than one year.
- 21. The payment will be made to the supplier after deduction of 3.5% Income Tax on each supply on production of receipt/certificate to the effect that the items received by the respective officer Incharge of the stores, to whom supply order is made.
- 22. All the rates quoted must be inclusive of all the taxes imposed by the Government, from time to time i.e GST etc. (present & future) in case may be.
