NOTICE INVITING TENDER

Sealed Bid in single envelope method from all the interested Bidders under SPPRA Rules 2010 who meet the following qualification criteria :

- i. List of similar assignments with cost (at least three) under-taken over the past 2 years.
- ii. Details of machinery and equipments to carry out the works owned by the Bidders.
- iii. Financial statement (summary) and income tax return for the last 2 years.
- iv. List of litigation (if any) and nature of litigation.
- v. Affidavit that the firm has never been black listed.
- vi. In case of PEC registration, only PEC certificate and NTN are required.
- vii. Electric License are required.

The tender documents should accompany the 2% earnest money of the estimated cost mentioned in the list in the shape of pay order or call deposit form any of the scheduled Banks duly pledged to the undersigned.

The conditional tenders will not be accepted and the Procuring Agency may reject all or any bids subject to the relevant provisions of the SPPRA Rules.
