PRE-QUALIFICATION OF CONTRACTORS (SCHOOL INFRASTRUCTRUE DEVELOPMENT / TOP UNDER SERP-II)

1. (PMIU) has received funds from Government of Sindh with the financial assistance of World Bank for the Project/Scheme cited above. PMIU is inviting Pre-Qualification of contractors because only Frame Structure will be constructed using ready mixed concrete to ensure the quality of construction. The contractors required for the project shall have in-house facility to check the quality of material during construction and submit the As-built drawings after completion of project to PMIU through the supervision consultants. The Scope, Estimated Cost and duration of project are as under:-

(i) Scope:

(Improve School Infrastructure in all Districts of Sindh).

(ii) Estimate Cost:

(Rs 35 - Rs 45 Million per Taluka/Town Packages).

(iii) Project Period:

(FY 2014/15).

2. Dead line of Submissions: Applications are invited from interested firms/contactors for pre-qualification. The application along with following documents must reach on the address mentioned herein below on or before 03:00 PM on February 17, 2015.

Works shall be carried out in all Regions in Sindh for which separate application is to be submitted for each Region clearly mentioning the region applied for:-

- Region–I, Karachi (Central Karachi, East Karachi, Korangi Karachi, Malir, South Karachi & West Karachi)
- Region-II, Hyderabad (Badin, Dadu, Hyderabad, Jamshoro, Matiari, Sujawal, TandoAllahyaar, Tando Muhammad Khan & Thatta),
- Region-III, Benazir Abad (Nausheroferoze, Sanghar and Shaheed Benazirabad),
- Region-IV, Larkana (Jacobabad, Kamber-Shahdadkot, Kashmore, Larkana, Shikarpur),
- Region-V, Sukkur (Ghotki, Khairpur Mirs and Sukkur)and
- > Region-VI, Mirpurkhas (Mirpurkhas, Tharparkar and Umerkot).

The prequalified contractors/firms will be invited to apply Region Wise. Contractors may apply for more than 01 Region. (Max 03 regions)

- 3. Eligibility. Valid Registration with Pakistan Engineering Council in the category C-5 and above for the Construction & Rehabilitation of Schools in Rural & Urban Areas of Sindh.
- 4. Required Documents: It must include following details/documents:-
 - (A) Profile of Firm/contractor: (15 Marks)
 - (i) Name, address, telephone, fax numbers and e-mail address of firm/individual;
 - (ii) Ownership and Organizational Structure of the firm
 - (iii) Year of establishment;
