
**3. Eligibility / Conditions:-**

- ii) List of work and copy of letter of award of work / work orders of equivalent cost or above.
- iii) List of machinery and equipment available with documentary proof of its ownership.
- iv) Registration with Income Tax Department (NTN copy) and Sindh Revenue Board, (Sales Tax Registration) and copy of CNIC.
- v) The application Shall accompany of tender fee as shown against each for purchase of bidding documents.
- vi) The 2% Earnest money shall be submitted in the shape of call deposit issued from scheduled bank at the time of submission of bidding document in favor of undersigned.
