

# NOTICE INVITING TENDERS (INTERNATIONAL COMPETITIVE BIDDING)

Chinese Loan

1. The Works & Services Department has received the loan from the Chinese Government towards the cost of Reconstruction of Nawabshah-Sanghar Road (60 Kms) and it is intended that part of the proceeds of the loan will be applied to eligible payments under the contract for the Reconstruction of 60 kms Road including rehabilitation of three bridges, construction of two new bridges, widening of 45 existing culverts and construction of 50 new box culverts. Bidding is open to pre-qualified contractors.
2. Procuring agency invites sealed bids from interested pre-qualified firms licensed by the Pakistan Engineering Council (PEC) in the Category C-A (No Limit) for the works and registered with Federal Board of Revenue (FBR) for Income Tax, Sales Tax in case of procurement of goods, registered with the Sindh Revenue Board in case of procurement of Works and Services.
3. Bidders may obtain information by acquiring the bidding documents (BD) from the office of the procuring agency with effect from February 25, 2015 during working hours at Bungalow No: B-1, G.O.R. Colony, Hyderabad.
4. A complete set of BD may be purchased by an interested bidder on submission of a written application to the above office and upon payment of a non-refundable fee of Rs. 20,000/- in the form of pay order or demand draft in favour of Project Director, Reconstruction of Nawabshah-Sanghar Road Project, Hyderabad. Additional set of Tender Documents excluding drawings may be purchased at Rs. 10,000/- each.
5. Pre-Bid meeting has been convened at 1100 hours on March 17, 2015, in the office of Project Director at Bungalow No: B-1, G.O.R. Colony, Hyderabad.
6. All bids must be accompanied by a bid security equivalent to 2% of the Bid amount in PKR or an equivalent amount in a freely convertible currency, and must be delivered to Project Director, Reconstruction of Nawabshah-Sanghar Road Project, Bungalow No: B-1, G.O.R. Colony, Hyderabad at or before 1400 hours on April 22, 2015. Bids will be opened at 1445 hours on the same day, in the presence of bidders representatives who choose to attend at the same address.

The applications of those firms including their subsidiaries and sub-contractor who are black listed by any government department or by any of International Donor Agency like IFC, World Bank, JISC, and ADB etc. shall be rejected without detailed evaluation. The applicant is required to submit undertaking on judicial paper that he or any of his associate/manufacturer/supplier/sub-contractor is not in the list of black listed firms

  12. Works & Services Department shall disqualify any applicant if it finds, at anytime, that the information submitted by him concerning his qualification is false and materially inaccurate or incomplete.
  13. Procuring agency reserves the right to annul the bidding process and reject all bids or proposals, as per Sindh Public Procurement Rules 2014.


