INVITATION FOR PREQUALIFICATIONS

The Project Director Flood Emergency Reconstruction Project (FERP) Hyderabad intends to invite applications from the reputed Contractors/Firms for the following schemes, under ADP No. 1035 (2014-15). Those having experience in Irrigation and Drainage Projects, specially the below mentioned flood protection works, also having License/Registration with Pakistan Engineering Council (PEC) in the relevant category C -3 valid for the year 2014-15 and discipline CE 03,04 and 10, for Pre-qualification to carry out the following works.

The Scheme includes earth work, stone pitching and stone filling etc for the above mentioned works in the respective areas.

1. Converting N.I.P Bank of Nara Distry RD-11 to 0 NIP of Khuda Waah Distry RD-0 to 39 into extension of Suprio Bund RD-0 to 50 in Rice Canal Division Larkana
2. Construction of Jherruck Flood Protection Bund from Mile 0/0 to 4/4 in Kalri Baghar Division Thatta
3. Raising, Strengthening and stone pitching along D/S R.M Bund Mile 0/0 to 9/0 in Guddu Barrage Division Kashmore.

The pre-qualification documents will be available from 26th February 2015 in the office of Project Director FERP Hyderabad @ Directorate of Hydrology & Research in Sindh opposite Saima Plaza Kali Mori Hyderabad on payment of Rs. 5000/- only in Cash (Non Refundable) on any working day during the office hours till 6th March 2015 @ 2.00 P.M. These documents can also be downloaded from SPPRA website.

The last date for submission of the Pre-qualification documents duly filled in is 6th March 2015. Application for pre-qualification must be delivered in sealed envelope by hand or through courier services to the office of undersigned not later than 6th March 2015 @ 2.00 P.M. the applicants who downloaded the documents from SPPRA website should pay Rs. 5000/- in cash at the time of submitting their documents. The documents received after 2.00 P.M shall not entertained. The same will be opened by the Procurement Committee in the presence of intending firms or their representative at 3.00 P.M on 6th March 2015.

Pre-qualification documents will be considered and evaluated in accordance with SPPRA rules 2010 and evaluation criteria adopted by the Irrigation Department, Govt. of Sindh.
