- Preparation of construction drawing of Architectural and Engineering Design i.e Structural, Electrical, Plumbing and infrastructure work etc (Which ever is applicable).

Planning, Architectural design shall be as per terms and condition of the contract.

Technical proposals will be opened by the constituted committee on the same day at 1500 hours whereas financial bids of the Technically Qualified Firms will be opened on 27th March 2015 at 1400 hours in the presence of the participants or their authorized representatives. (Evaluation will be carried out as per Pakistan Engineering Council Criteria).
