The terms and conditions for hiring of private Godowns are as under:-

- (i) The Godowns not be situated in low lying / flood hit / water logged / non-environment friendly area and should have easy access to main metalled road.
- (ii) The Godowns must have provision of electricity and water.
- (iii) The Godowns capacity of a unit should be a minimum of 500 Metric Tons with roof height of at least 20 ft.
- (iv) There should be no electrical leakage in the roofs or walls and must be fit for air tight arrangements (fumigation).
- (v) Floor of Godowns must be at a raised level compare to its surrounding areas.
- (vi) Floor and walls of the godowns should be plastered and pit free.
- (vii) To avoid long queues at the Godowns there should be enough room for maneuverability of vehicles (trolleys / trucks).
- (viii) From security point of view the Godowns space should have a boundary wall.
- (ix) The rent will payable only for the period the space is utilized and in this connection 15 days notice will be sufficient.
