The pre-qualification document will be issued from 9th March 2015 to 24th March 2015, the last date for submission of the proposals is 25th March 2015 at 12:00 (Noon) and opened on same day at 1:00 PM in presence of interested bidders or their representatives.

The bidding documents will be issued to prequalified/short listed contractors/firms only.

The interested Firms / Contractors are required to submit the following information.

1. Name of firm along with permanent address, telephone number & Email address.
2. Bio-data of permanent technical staff along with managerial and organizational set up.
3. List of works executed during the last 10 years especially in water sector along with estimated cost and name of client.
4. List of plants, equipments, transports and machineries available with the firm
5. Copy of valid certificate of Pakistan Engineering Council in category C-1
6. Affidavit on stamp paper by firms /contractors to the effect that neither firms/contractors have ever been black listed / defaulted nor involved in legislation with any Government Department.
7. An undertaking in which the information supplied by the firms/contractors should be correct.
8. Proof of financial capability including Income Tax Return of last 03 years.
9. Credit line certificate from the reputable bank.
10. The contractor/firm should be registered with Sindh Revenue Board.
11. Any additional information with supporting documents.



The proposals / prequalification documents will be considered and evaluated in accordance with SPPRA Rules 2010. The interested contractors / firms may obtain any further details regarding the project on any working day before submission of the proposals. The proposals in English shall be submitted in three (03) copies in sealed cover so as to reach the office of the undersigned and not later than closing of office hours.

The intending contractors / firms can apply either in consortium or singly also the consortium consisting of more than three (03) firms will not be eligible for the participation. If firms do not supply the full information in accordance with requirement of the advertisement, the proposal shall be considered as non-responsive. Further the intending contractor has to submit the undertaking for completion of work within stipulated time as fixed by the procuring Agency. Time limit bears imperative and unalterable binding upon the intending firms.

Conditional and late application shall not be considered.

The Procuring Agency may reject all or any bid subject to relevant provision of SPPRA Rules 2010.
