(NIT)**

1. **Sindh Transmission & Dispatch Company (STDC)** (the Employer), an entity wholly owned by Government of Sindh, intends to invite sealed tenders from EPC contractors for construction works of 132kV transmission line to evacuate 100 MWs from power plant located at Nooriabad, 132kV Grid Station, located at Karachi, (approximately 90 km) through open competitive bidding process.

For Joint Venture, lead partner shall have the above criteria and other partners shall have minimum registration in C2 and annual turnover 200 Million PKR minimum)

- (a) Under following conditions bid will be rejected:-
- (i) Conditional and telegraphic bids/tenders;
- (ii) Bids not accompanied by bid security of required amount and form;
- (iii) Bids received after specified date and time.
- (iv) Black listed firms.
- (b) **Bid validity Period: - 120 days**
- (c) Procuring Agency reserves the right to reject all or any bids subject to the relevant provisions of Sindh Public Procurement Rules 2010, amended time to time.

- (i) List of similar assignments with cost (*mention number of projects with their cost*) under-taken over the past (10) years;
- (ii) *Details of equipments, machineries and transport owned by firm/contractor;*
- (iii) Financial Statement (summary) and income tax return for the last 03 years;
- (iv) Affidavit that firm has never been black listed
- (v) In addition to that the Bidder should fulfill the whatsoever conditions prescribed in the Bidding Documents.
