- Lead the preparation of a Situation Analysis relevant to the provisions of the Act.
- Assist the department in the preparation of a Work Plan for the implementation of the Act.
- Lead a review of policy and program options including costing of scenarios.
- Lead the preparation of annual Sindh Education Report to track progress in the implementation of the Act and other related issues concerning education of children up to the secondary school age.
- Other issues pertaining to the Act.
