In accordance with Public Procurement Rules, 2010, the Police Department, Government of Sindh, invites tenders from Manufacturer / Authorized Dealers registered with FBR and Income Tax Department for the Procurement of following Transport for Traffic Police, Karachi:-

### INSTRUCTION:

1. **SINGLE STAGE - TWO ENVELOPES** procedure will be adopted for the tender process. Bids shall comprise of a single package containing two separate envelopes. Each envelope shall contain separately sealed financial proposal and technical proposal. Envelopes shall be marked as "**FINANCIAL PROPOSAL**" and "**TECHNICAL PROPOSAL**" in bold and legible letters to avoid confusion.
2. Only manufacturer/authorized dealers registered with Income Tax and Sales Tax Departments are eligible to participate in the tender (documentary proof required).
3. Tender documents can be obtained on submission of a written request on company's letterhead and tender fee in the form of Pay Order / Demand Draft / Cash along with copy of NTN, GST, Provisional Sales Tax (where applicable) CNIC (authorized representative of the firm) from 6<sup>th</sup> April during working days between 9:30 AM to 05:00 PM from following address:

4. Sealed tenders on prescribed proforma in duplicate along with 2% earnest money of the total bid in form of Pay Order / Demand Draft in favor of **ASSISTANT INSPECTOR GENERAL OF POLICE, MOTOR TRANSPORT, SINDH, KARACHI** should be dropped in tender box placed at CPO Conference Room Ground Floor, I.I Chundrigar Road, Karachi ON 24<sup>th</sup> April 2015 between 09:30 AM to 14:00 hrs.
5. The tender will be opened on 24<sup>th</sup> April at 1430 hrs., by the Purchase Committee

and in the presence of bidders or their authorized representative (having valid authority letter from their respective company) at CPO Conference Room Ground Floor, I.I Chundrigar Road, Karachi.

6. Only bids offered on the prescribed tender form issued by the Police Department shall be accepted. However additional sheet can be attached, if required.
7. Conditional tender / application will not be entertained.
8. Competent authority can cancel the bidding process at any time prior to the acceptance of proposal as per provision of Rule-25(1) of SPPRA Rules 2010.
9. Competent authority reserves the right to increase / decrease quantity of aforementioned item(s) and to accept or reject any or all applications or tenders as per rule and no claim whatsoever, will be entertained in this regard. Authority's decision in this respect shall be final.
