 - iv) The Firm must be register in PEC with specialization code and also be registered with Sindh Board of Revenue for the year 2015.

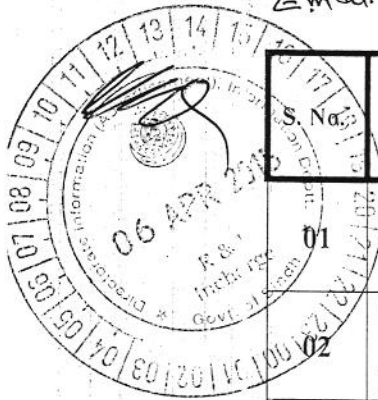




