- The Tender Document will be issued to the Contractors on the submission of written request on their letterhead and on payment of non-refundable cost of tender price through pay order from any scheduled bank in favors of District Municipal Corporation, Malir Karachi as mentioned above each work. The photocopy of P.E.C. Registration Certificate should be enclosed with the bid otherwise the tender will be rejected. No tender will be sold on tender opening date. P.E.C registration not required for 1.00 Million.
- In case of any reason beyond our control, if the tenders are not responded on the above date, the next date of submission & opening of Tenders will be 15-05-2015 at 12:00 pm and the tender documents will be available for sale from 30-04-2015.
- In case the date of opening is declared as a public holiday by the government, the next official working day shall be deemed to the date for submission and opening of tenders of the same time as mentioned.
- Registration with income tax Department (NTN Copy) and Sindh Revenue Board.
- Documentary of work equivalent cost or above executed in last 3 years & Certificate of satisfactory completion showing date of start & completion from employer.
