Technical & Financial bids shall be submitted in separate envelopes along with bid security of 2.5% of bid quoted in shape of pay order /demand draft form any 3cheduled bank in favour of Director, Directorate of Human Rights, Government of Sindh, must be attached with financial bids signed by the authorized person or firm.
- 3. All bids shall include Government taxes, as applicable under Government's policy.
- 4. Rates offered by the bidder shall be valid till the end stage.
- 5. Bids must be in Pak Rupees. Any condition bids or bids received beyond the above mentioned schedule will not be entertained.

Technical & Financial bids shall be submitted in separate envelopes along with bid security of 2.5% of bid quoted in shape of pay order /demand draft form any scheduled bank in favour of Director, Directorate of Human Rights, Government of Sindh, must be attached with financial bids signed by the authorized person or firm.
- **6.** The Procurement Committee shall awarding the agency after the considering all short listed proposals in detailed.
- 7. The successful tenderers shall deposit security in the form of pay order/demand draft in favour of Director, Directorate of Human Rights at the value 10% of the contract amount.
- **8.** If the work is not completed in accordance with the delivery period given in the purchase order the Directorate shall be at liberty to get completed the same from elsewhere at the expense of the supplier without any notice.
- 9. The supplier will not transfer or assign directly or indirectly to any person or person what so ever any portion of the contracted work without the prior consent of the Directorate, subletting shall be prohibited.
- 10. The supplier shall pay all such expenses, costs, charges, taxes, duties and / or levies as may be payable for completing the required work.
- 11. The Procurement Committee may reject all bids or proposals, at any time prior to the acceptance of a bid or proposal subject to the relevant provision of Sindh PPRA rules.
- 12. Any dispute or difference relating to this contract shall be settled by a sole arbitrator to be mutually nominated, in accordance with the provisions of the Arbitration Act 1940.
