The tender will be opened at 2:30 P.M by the Procurement Committee i.e. the Superintending Engineer, Provincial Buildings Circle Hyderabad, Executive Engineer Augaf Department Hyderabad and the Undersigned in presence of the Contractors or their authorized agents who are present at the time, other terms and conditions can be seen in the office of the undersigned on any working day during working hours.
- 4. In case of any member of the Procurement Committee happens to be out of the Head Quarter, the bids will be submitted and open on next working day.
- 5. Eligibility conditions for intending participants are as under:
- Registration with Pakistan Engineering Council in the relevant field of specialization is required for works costing 4.00 Million & above.
- ii) Registration with Sindh Revenue Board is required in term of Rule-46(1)(iii) of SPP Rules'2010 (amended 2014).
- iii) Documentary evidence of works executed/works in progress and certificate of satisfactory completion of works by the employers.
