The Photo Copy of P.E.C registration certificate is not required upto 4.00 Million.
4. Photocopy of Registration certificate with Sindh Board of revenue is required from all participant/ contractors, otherwise tender will not be issued.
5. In case the date of opening declared as a public holiday by the Government, the next official working day shall be deemed to be the date for submission and opening of the same time as mentioned.
6. 2% of specified amount against each work in shape of pay order/Bank draft in favour of DMC Korangi Karachi shall be attached with the Tender.
7. Tender in unsealed cover and without 2% earnest money will not be entertained and discarded.
8. The Single Envelope procedure adopt for tender work as per SPPRA rules.
9. the Total bid amount as well as the rate of items must be filled both in figure and words and in case my correction is made by the contractor himself then each correction must be initiated by the contractor otherwise the Tenders are liable to be summarily rejected.
10. If any fake documents are found then the tender is liable to be rejected/cancelled without any compensation but penalty will be imposed as per rule.
