Only the bids submitted with the document fee will be considered as eligible for participation in the bidding process.
- 3. The bid shall comprise a single package two separate envelops inside. Each a sealed bid, envelop shall contain separately the "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL", as per the SPPR Rules 2010.
- On scheduled date of bid opening, only envelops of "TECHNICAL PROPOSAL" will be opened and envelop marked "FINANCIAL PROPOSAL" will be retained in the safe custody as per SPPRA RULES 2010.
- After Technical Evaluation, envelope of "FINANCIAL PROPOSAL" of technically accepted bidders will be opened with prior intimation to successful bidder(s). The FINANCIAL PROPOSAL of bids found technically non-conforming will be returned unopened to the respective bidder, as per SPPRA RULES 2010.

8. Eligibility Conditions as per SPPRA RULES 2010 Section 46(2), for tender participants are as under:-

Eligibility Criteria

- a) Registration with Income Tax Department (NTN) Certificate.
- b) Registration with Sales Tax Department (GST) Certificate.
- c) Registration with Sindh Revenue Board (PST) Certificate.

Qualification Criteria:

- a) Minimum three years' experience of relevant field.
- b) Turnover of at least last three years
- c) Required Bid Security is attached.
- d) Bid is signed, named and stamped by the authorized person of the firm along with Authorization letter.
- e) Documentary evidence of similar services of supplies & services completed and certificate of satisfactory completion for last three (03) years.
- 9. The Bidder should submit an undertaking on Affidavit that firm is not involved in any litigation or abandoned any work in any department.
- 10. The Bidder should submit bid security @ 2% in shape of Call Deposit / Pay Order / Demand Draft prepared from any schedule bank in favor of undersigned.
- 11. Project Management Unit, Board of Revenue Sindh may cancel the bidding process at any time prior to the acceptance of a bid or proposal under Rule 25 (1) of SPP Rules 2010."
- 12. The procuring agency shall announce the results of bid evaluation in the form of a report, giving justification for acceptance of a bid or proposal, subject to the relevant provision of SPPRA RULES 2010.
