3. Sealed bids accompanied with the earnest money as mentioned against each, in shape of Pay Order must be submitted in the office of undersigned on or before 20-05-2015 upto 3:30 p.m.(1st Attempt) & on 10-06-2015 upto 3.30 p.m. (in case of un-responded/ 2nd attempt)

 - b. Registration with Sindh Revenue Board.
 - c. Bio Data of Engineers and Technical staff working with the firm.
 - d. Documentary evidence of similar works executed/ works in progress and certificate of satisfactory completion of works by the employees. Particularly same nature of works.
