3. Sealed bids accompanied with the earnest money as mentioned against each, in shape of Pay Order must be submitted in the office of undersigned on or before 20-05-2015 upto 3:30 p.m.( 1<sup>st</sup> Attempt) & on 10-06-2015 upto 3.30 p.m. (in case of un-responded/ 2<sup>nd</sup> attempt)
