The sealed tenders can be dropped in the Tender Box at 01.00 p.m. on the same date of opening. The tenders will be opened in presence of the bidders or their authorized representative who wish to be present.

**Note:-**

- a) Tender bids are required on free delivery basis in Pakistan currency.
- b) Tenders should be submitted duly sealed, otherwise these will be rejected.
- c) In case of declared holiday by the Government, tenders will be opened on the next working day.
- d) Bid Security in shape of pay order in favour of Secretary Food, Food Department, Govt. of Sindh, and Karachi will have to be submitted along with the tender @ 5% of the quotation rate.
- e) Procuring Agency may reject all or any bid subject to the relevant provisions of Public Procurement Rules 2010.
- f) Tenders should be submitted in the name of Secretary, Food Department, before the closing date and time mentioned in the tender enquiry.
- g) The successful bidder would be liable to pay Security Deposit @ 10% of the value of the offer.
- h) Food Department reserves the right to increase or decrease the scope of work/number of items without assigning any reason.
- i) All taxes applicable under Federal / Provincial / Local Government will be deducted at the time of payment to the contractor.
- j) The bids shall be based on Single Stage containing one envelope procedure as provided in SPPRA Rules, 2010.
- k) Financial Proposal shall be opened at a time, date and venue announced and communicated to bidders in advance.
