INTERNATIONAL COMPETITIVE BIDDING

1. The Executive Engineer, Provincial Highway Division, Dadu has received funds from Government of Sindh towards the cost of "Construction of Over Head Bridge on Railway Line Between Kotri City and the Industrial Area Kotri, District Jamshoro Sindh" (ADP No. 2895) and it is intended that part of the proceeds of the funds will be applied to eligible payments under the contract for the "Construction of Over Head Bridge on Railway Line Between Kotri City and the Industrial Area Kotri, District Jamshoro (Including road work and approaches)". Bidding is open to all eligible interested bidders.
2. Procuring agency invites bids from eligible interested firms or persons licensed by the Pakistan Engineering Council (PEC) in the category CA (no limit) or above for the works and in discipline CE-01 & CE-02 and registered with relevant tax authorities. Federal Board of Revenue (FBR) for Income Tax, Sales Tax in procurement of goods, registered with the Sindh Revenue Board in case of procurement of services. A foreign bidder is entitled to bid only in a joint venture with a Pakistani firm in accordance with the relevant provisions of PEC bye-laws.
3. Bidders may obtain information by acquiring the bidding documents (BD) from the Office of the procuring agency, up to 26-06-2015 during office working hours at Executive Engineer, Provincial Highway Division, Dadu.
4. Pre-Bid meeting has been conveyed at 1300 hours on 17-06-2015 in office of the Executive Engineer, Provincial Highway Division, Dadu.

10. In case of any member of procurement committee happens to be out of Head Quarter on the date of opening, bids will be submitted and opened on next working day.


