NOTICE INVITING TENDER

The Principal, Police Recruits Training Centre, Hyderabad invites sealed Bids / Tenders from interested firms or persons licenced by the Pakistan Engineering Council (PEC) in the relevant category and registered with relevant Tax authorities on Standard Bidding Documents of SPPRA as per Rules 2010 (amended to-date). PEC Licence not required for the works costing upto Rs.2.500 million. A Foreign Bidder is entitled to Bid only in a joint venture with a Pakistani Firm in accordance with the relevant provisions of PEC Bye-laws.


2. Bidder / Contractor should be registered with Sindh Revenue Board in terms of Rule-46(1)(iii) of SPP Rules, 2010 (amended to date)
3. Bidding is open to all interested bidders.
4. Method of Procurement i.e. Single Stage, Single Envelope.
5. Bidders may obtain information by acquiring the Bidding Documents (BD) from the Office of the Principal, Police Recruits Training Centre, Ganjo Takar, Hyderabad from the date of publication to **25.05.2015 upto 2.00pm**.
6. A complete set of BD may be purchased by an interested Bidder on submission of a written application to the above office and upon payment of a non-refundable fee as shown against each work.
7. All Bids must be accompanied by a Bid Security of 2% of Bid Amount in shape of Call Deposit or Pay Order only and must be delivered to office of the Principal, Police Recruits Training Centre, Ganjo Takar, Hyderabad **at or before 2.30 hours, on 26.05.2015. Bids will be opened at 3.00 hours on the same day**, in the presence of Bidder's representatives who choose to attend at the same address.
8. Un-responded tenders will be again issued / submitted / opened on following dates 2nd attempt (a) **issue date from 27.05.2015 to 10.06.2015 upto 2.00pm** (b) **submission at or before 2.30 hours on 12.06.2015** (c) **Bids will be opened at 3.00 hours on the same day**, in the presence of Bidder's representatives who choose to attend at the same address on above quoted place.
9. **TERMS & CONDITIONS.**
 - (a) Under following conditions bid will be rejected:-
 - i) Conditional and telegraphic bids / tenders.
 - ii) Bids not accompanied by bid security of required amount in shape of call deposit or pay orders only.
 - iii) Bids received after specified date and time.
 - iv) Black listed firms / persons.
10. Bid Validity Period is (60) Sixty days.

11. The successful Bidders whose bids are accepted will have to obtain adhesive stamps from Assistant Superintendent Stamps, Government of Sindh, Karachi or District Accounts Officer, Hyderabad on payment of Stamps fees according to Schedule prescribed in the Sixth Finance Act 1996 amended rule to date.

12. Bidders who fail to qualify in any of the above sections shall be disqualified from the bidding process as per SPP Rules 2010 (amended to-date).

13. Procuring agency reserve right to annul the bidding process and reject all bids or proposals, as per SPP Rules 2010 (amended to-date).
