- The tender documents will be issued to contractor on submission of written request on letter head and on payment of non-refundable cost of tender price through pay order from Sindh Bank in favour of SITE Zone DMC (West).
- The Bid Security as mentioned above in shape of pay order in favour of SITE Zone DMC (West) shall must be enclosed with tender documents without which the tender will be treated as cancelled.
- In case the date of opening is declared as a public holiday by the Government, the next official working day shall be deemed to be the date for submission and opening of tenders at the same time as mentioned.

5. The total bid amount as well as the rates of items must be filled both in figures and words and in case any correction is made by the contractor himself then each correction must be initialed by the contractor; otherwise the tenders are liable to be summarily rejected.
