Hyderabad.

Tender comprising of Technical Proposal and Financial proposals must be submitted in separate sealed envelopes with clear marking of "TECHNICAL PROPOSAL" AND "FINANCIAL PROPOSAL" & will be received back on 09 / 06/2015 upto 11.00 A.M from the issuing office. Technical Proposal of the participating firms will be opened on the same day at 12.00 Noon by the Tender Opening Committee in presence of participating contractors / firms or their authorized representatives of the firms who wish to be present.
3. The TECHNICAL PROPOSAL so opened shall be evaluated for technical qualification of the firms. Financial bids / proposals of the technically qualified firms shall be opened and publicly announced on the date and time that will be communicated in writing to all the qualified contractors / firms in advance. Financial bid / proposal of technically un-qualified contractors shall be returned to them un-opened.
4. Tenders shall be carefully & neatly filed and signed by the bidders. Each bid must accompany the Earnest Money as mentioned below in shape of Deposit at Call in favour of Managing Director, WASA, HDA; Hyderabad. Bid Security shall be submitted in the sealed envelope named "Financial Proposal". Incomplete tender, over-writing or conditional tender shall not be entertained.
5. Registration certificate from Pakistan Engineering Council on appropriate category to the value of each work for the year, 2014-2015.
6. Registration with Income tax Department (NTN copy) and Sindh Revenue Board (Sale Tax Registration) and copy of CNIC.

7. Technical proposal must contain company profile with following information.
  - a. List of works of similar nature and size for each completed in last 3 /5 years, with documentary evidence along with satisfactory completion certificate of works from employer and details of ongoing works of similar nature with copies of letter of award of works.
  - b. Details of machinery and equipment available for execution of work with documentary evidence of ownership.
  - c. Qualification and experience of technical personnel and key site management.
  - d. Bank statement of last 3 years showing the credit limit.

- f. Affidavit regarding not indulged in litigations and abandoned any works.
- g. Affidavit that the firm is not black listed in past by any procurement agency.
- h. Affidavit that the given information, documents and data is absolutely true and correct.
8. The tender must accompany call deposit or demand draft or pay order of any schedule bank of Pakistan of the amount shown against each work duly pledged in favour of MD, WASA,
9. In case of undesirable circumstances on sub mission / opening date and time or if Government declares Holidays the tender shall be submitted / opened on the next working day at the same time and venue.
