The Program Management & Implementation Unit (PMIU), Education & Literacy Department, Government of Sindh (the "Procuring Agency" "PA") has received funds from the United States Agency for International Development (USAID) towards the cost of construction of schools in selected districts of Sindh and it is intended that part of the proceeds of the funds will be applied to eligible payments under the contract for **Package No: SBEP-P09-DADU-II, "Construction of Six (06) School in District Dadu (KN Shah & Mehar)"**
2. PA invites sealed bids for the above mentioned works from interested firms prequalified for Sind Basic Education Program (SBEP). Bidders may obtain information from the bidding documents (BD). A complete set of bidding documents in soft format (CD) is being dispatched here with to all pre-qualified firms at their given postal addresses. Bidders may also acquire BD (soft) from the office of the PA (address as above), free of cost.

All bids must be accompanied by a Bid Security in the amount equivalent to 1.25% of quoted bid price in Pak Rupees or an equivalent amount in a freely convertible currency either in the form of Pay Order / Call Deposit / Demand Draft / Bank Guarantee from any schedule Bank of Pakistan in favor of Program Director, PMIU-Sindh Basic Education Program, Education & Literacy Department, Govt. of Sindh, and must be delivered / dropped in the tender box placed with the Procuring officer at SBEP PMIU Office (address as above) before or up till **1100 hours, on 19<sup>th</sup> June, 2015**.
