Meanwhile, residents of the affected areas, irked by the long power outages, have held several demonstrations and sit-ins, but their protests have gone unheeded thus far.

For his part, the sub-divisional officer for old Sukkur, Israr Bajkani, told *The Express Tribune* that the heavy transformer was the responsibility of the senior officials of the power utility. Bajkani alleged that power theft had become rampant and when their teams raided different areas to remove the ille-
