Sealed Tenders are invited from interested contractors / companies / firms registered with Pakistan Engineering Council in particular category and meeting the criteria under the PPRA Rules, 2004 for drilling and installation of tubewells (underground) in the Arid Zones of districts of Tharparkar, Badin, Jamshoro / Dadu and Thatta.

The interested companies / firms / contractors having adequate experience in the drilling works are required to furnish technical as well as financial proposals in sealed package containing two separate envelopes i.e. Technical Proposals and Financial Proposals. The technical proposal should contain following information:-

- a) Company profile
- b) Relevant experience in drilling. Projects completed, operated as contractor.
- c) Drilling conducted (especially straight, rotary) or supervised.
- d) Reference of similar works along with execution certificate
- e) Capabilities with respect to personnel, equipment and machinery for the execution of works viz. drilling and assessment of water resources
 - i) List of equipments and plants required for these works available with them
 - ii) List of technical manpower on their payroll with relevant experience
- f) Details of the projects under execution, negotiations / completed.
- g) Financial status of the company.

CONDITIONS:

- 1. All bids / tenders in sealed envelopes accompanied with bid security at 4% of bid price in the form of bank draft/pay order in favour of Director General, Sindh Coal Authority must be submitted with each offer. The Bid Proposal for Drilling & Installation of Tubewells should be marked on the envelop.
- 2. A set of Bidding Documents containing detailed terms & conditions, specification of works can be obtained on written request from the Sindh Coal Authority office on payment of a non-refundable fee of Rs.2000/- on any working day upto 1100PST on or before 20 March, 2009.
