DESIGN REVIEW & CONSTRUCTION SUPERVISION OF CONSTRUCTION OF OVER HEAD BRIDGE ON RAILWAY LINE BETWEEN KOTRI CITY AND THE INDUSTRIAL AREA KOTRI, DISTRICT JAMSHORO SINDH" (ADP NO. 2318 OF 2015-16).

1. The Works & Services has received ADP funds for Construction of Over Head Bridge on Railway Line Between Kotri City and the Industrial Area Kotri, District Jamshoro Sindh" (ADP No. 2318 OF 2015-16) and it is intended that part of the proceeds of Government of Sindh's funding will be applied to eligible payments under the Consultancy Contract.
2. Procuring agency invites reputed leading consulting firms registered with Pakistan Engineering Council and Federal Board of Revenue (FBR) for Income Tax, Sales Tax and Sindh Revenue Board.
3. Interested Consultant firms may obtain RFP documents on payment of Rs. 3000 in shape of Pay Order or Demand Draft from office of Executive Engineer, Provincial Highways Division, Dadu opposite Sikander Petroleum Service Dadu-Johi Road, Dadu from the date of publication in newspaper during office timings or RFPs can be downloaded from SPPRA website and submit their proposals on or before 13-07-2015 Upto 1300 hours and the same will be opened on the same day at 1330 PM before the Consultant Selection Committee and in presence of Consulting firms representative who chose to attend the meeting.
4. The bid Security shall be submitted along with Financial Proposal in the shape of Bank Guarantee / Call Deposit / Pay Order equivalent to 1% of the Consulting Services Cost.
5. The applications of those firms including their subsidiaries and sub-contractor who are blacklisted by any government department or by nay of International Donor Agency like IFC, World Bank, JISC and ADB etc shall be rejected without detailed evaluation. The applicant is required to submit undertaking on judicial paper that he or any of his any of his associate / manufacturer / supplier / sub-contractor is not in the list of blacklisted firms of the above mentioned departments or financing institutions, the undertaking should be duly notarized.
6. An affidavit to the effect that all documents / particulars / information given with this qualification document are true.
7. An affidavit to the effect that the Applicant has never indulged in corrupt, fraudulent or collusive practice for procuring contracts.
