The photo Copy of P.E.C. Registration Certificate should be enclosed with the bid otherwise the tender will be rejected .No tender will be sold on the tender opening date .

3-In case of any reason , if the tenders are not responded on the above date the next date of submission and opening will be 12.8.2015 and the tender document will be available for sale from 27.7.2015.

4-Incase the date of opening is declared as a public holiday by the government , the next official working day shall be deemed to the date for submission and opening of tenders of the same time as mentioned .

5-2% of specified amount against each work in shape of pay order/Bank draft in favor of District Council Karachi shall be attached with the tender.

6-Tenders in unsealed cover /without 2% earnest money will be not be entertained and discarded.

7-The single envelop procedure adopted for tender work as per SPPRA Rules.

8-The total bid amount as well as the rates of items must be filled both in figure and words and incase any correction is made by the contractor himself then each correction must be initiated by the contractor otherwise the tenders are liable to be summarily rejected .
