The bidding documents will be issued to the interested Firms/Contractors on submission of written request on letter head and on payment of non-refundable cost of tender price mentioned against each work, through pay order from any scheduled Bank in favor of **Keamari Zone, DMC(West), Karachi**, and bidding document can also be downloaded from the SPPRA Website (www.pprasindh.gov.pk) with tender fee mentioned as above by mail or by hand.

The Earnest Money equal 2% of offered rates/amount of Open Rate items and Earnest Money of schedule items mentioned against each work in shape of pay order from any scheduled Bank in favour of **Keamari Zone, DMC(West), Karachi** must be enclosed with tender documents, otherwise the tender will be rejected.
