- 6. 2% of quoted amount against each work in shape of pay order / bank draft in favor of DMC Korangi Karachi shall be attached with the tender.
- 7. Tender in unsealed cover and without 2% earnest money will not be entertained and discarded.
- 8. The single stage-one Envelope procedure would be adopted for tender work as per SPPRA Rules.46(1)
