4. Photocopy of Registration certificate with Sindh Board of revenue is required to submit by all participants along with bidding document at the time of dropping in Tender box.
5. In case of holiday and unforeseen circumstances on opening date the bids shall be submitted and opened on the next working day, other terms and condition shall remain same.
6. 2% of quoted amount against each work in shape of pay order / bank draft in favor of DMC Korangi Karachi shall be attached with the tender.
7. Tender in unsealed cover and without 2% earnest money will not be entertained and discarded.
8. The single stage-one Envelope procedure would be adopted for tender work as per SPPRA Rules.46(1)

Total bid amount as well as the rate of items must be filled both in figure and words and in case any correction is made by the contractor himself then each correction must be initiated by the contractor otherwise the tenders are liable to be summarily rejected / cancelled without any compensation but penalty will be imposed as per rule.
10. If any fake documents are found than the tender is liable to be rejected / cancelled without any compensation but penalty will be imposed as per rule.
