 3. There is one lot in this IFB. The bids will be evaluated based on total cost (excluding local taxes), not on individual items.

Bidding process will be conducted using the National Competitive Bidding (NCB) procedures specified in the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting services under IBRD Loans and IDA Credits & Grants, edition of January 2011, revision July 2014, and is open to all Bidders eligible as defined in these Guidelines.
 5. Qualifications requirements are included in the Section III of the bidding document.
 6. Interested eligible bidders may obtain further information from Reform Support Unit, NJV School Building, M.A Jinnah Road, Karachi and inspect the bidding documents at the address given below from 10:00 Hrs. to 16:00 Hrs. Monday to Friday.
