3. The tender shall be opened on 25.04.2009 at 13:30 hours in presence of Purchase Committee and in presence of representatives of bidders who choose to be present on the occasion, in the Committee Room of Central Police Office, Sindh, Ground Floor, I.I.Chundrigar Road, Karachi.
4. Only firms/Companies registered with Income Tax and Sales Tax department are eligible to participate in the tenders (Documentary proof required).
5. Only bids offered on the prescribed tender form issued by the Police department shall be accepted. However, additional sheets may be attached, if required.
6. Conditional tender /Conditional offer and unit price verification on certain conditions will not be entertained.
