NOTICE INVITING TENDER

Sealed Tenders are invited from interested firms/ contractors under Sindh Public Procurement Rules (SPPRA) 2010 for the following works:

1. Interested eligible bidders may obtain further information on the bid and collect the bidding documents from the office of Project Director, Project Management Unit, Reforms Wing & Special Cell, Board of Revenue, Government of Sindh, adjacent Dr. Ziauddin Hospital, Clifton, Karachi, Tel: +92-21-99251367-68 / Fax: +92-21-35305586 from **Wednesday 14th October 2015** during office Hours, i.e. **9:00 am to 5:00 pm** on payment of document fee of **Rs. 2,000/-** in the form of **Pay order/Demand Draft in favour of Project Director PMU, Board of Revenue, Sindh** till **12:00 PM on Thursday 29th October 2015**.
2. The bidding document can also be downloaded from the website of SPPRA, i.e. www.pprasindh.gov.pk or the website of PMU, BOR, i.e. www.sindhlarms.gos.pk, in which case document fee may be submitted alongwith the bid. Only the bids submitted with the document fee will be considered as eligible for participation in the bidding process.
3. The bid shall comprise a single package two separate envelopes inside. Each a sealed bid, envelop shall contain separately the "**FINANCIAL PROPOSAL**" and "**TECHNICAL PROPOSAL**", as per the SPPR Rules 2010.
4. On scheduled date of bid opening, only envelopes of "**TECHNICAL PROPOSAL**" will be opened and envelop marked "**FINANCIAL PROPOSAL**" will be retained in the safe custody as per SPPRA RULES 2010.
5. After Technical Evaluation, envelope of "**FINANCIAL PROPOSAL**" of technically accepted bidders will be opened with prior intimation to successful bidder(s). The **FINANCIAL PROPOSAL** of bids found technically non-conforming will be returned unopened to the respective bidder, as per SPPRA RULES 2010.
6. Proposal should be submitted on or before **Thursday 29th October 2015** at **03:00 pm** at the office of Project Director, Project Management Unit, Reforms Wing & Special Cell, Board of Revenue, Government of Sindh, adjacent Dr. Ziauddin Hospital, Clifton, Karachi, Tel: +92-21-99251367-68 / Fax: +92-21-35305586/99251373.
7. The proposals submitted against the subject RFP will be opened on **Thursday 29th October 2015** at **03:30 pm** in the committee room of Project Management Unit, Reforms Wing & Special Cell, Board of Revenue, Government of Sindh, adjacent Dr. Ziauddin Hospital, Clifton, Karachi, Tel: +92-21-99251367-68 / Fax: +92-21-35305586 in presence of all the bidders, or their representatives, who may choose to be present.
8. Eligibility Conditions as per SPPRA RULES 2010 Section 46(2), for tender participants are as under:-
 - The Bidder must be registered with SECP under the Companies Ordinance 1984;
 - The Bidders must be registered with Federal Board of Revenue (FBR) for Income Tax and Sales Tax and must be on FBR's Active Taxpayers List.



- The Bidders must be registered with Sindh Revenue Board (SRB) for Provincial Sales Tax and must be on SRB's Active Taxpayers List.
 - The Bidders must be able to demonstrate that they have expertise in performing the tasks enlisted under scope of work.
 - Bidders may submit bids as a Joint Venture but in such case one bidder shall be appointed as a lead bidder who shall be solely responsible for end to end delivery of the entire project.
 - Bidders or any of its consortium partners must not have been black listed or declared bankrupt by any Government or Financial institution.
 - Bidders NOT complying with any of the above eligibility pre-requisites would be disqualified. All documentary evidence must be submitted along with the bids; no document will be acceptable after bid submission.
 - The Bidder must provide the Authorization Letter from partner of satellite image provider.
9. The Bidder should submit an undertaking on Affidavit that firm is not involved in any litigation or abandoned any work in any department.
10. The Bidder should submit bid security @ 2% in shape of Call Deposit / Pay Order / Demand Draft prepared from any schedule bank in favor of undersigned.
11. Project Management Unit, Board of Revenue Sindh may cancel the bidding process at any time prior to the acceptance of a bid or proposal under Rule 25 (1) of SPP Rules 2010."
12. The procuring agency shall announce the results of bid evaluation in the form of a report, giving justification for acceptance of a bid or proposal, subject to the relevant provision of SPPRA RULES 2010.
