Construction of Seven (07) Schools in District Qambar Shahdadkot (Talukas Naseerabad & Warah)

The Sindh Basic Education Program (SBEP), Program Management & Implementation Unit (PMIU), Education & Literacy Department. Government of Sindh (the "Procuring Agency" "PA") has received funds from the United States Agency for International Development (USAID) towards the cost of construction of schools in selected districts of Sindh and it is intended that part towards will be applied to eligible payments under the contract for Package No: SBEP-P10-of unds will be applied to eligible payments under the contract for Package No: SBEP-P10-QSK-I: Construction of Seven (07) Schools in District Qambar Shahdadkot (Talukas Naseerabad & Warah), Sindh.

PA invites sealed bids, under Single Stage-One Envelope bidding procedure as per SPP Rules 2010, from reputed & eligible Contractor Firms/Companies registered with Pakistan Engineering Control (PEC) in Category C-2 & above and experienced in Building Works/Projects. The firms/companies must also be registered with relevant Government Departments and Taxation Au horities (FBR & SRB). The Contractor firms already Pre-Qualified for Sindh Basic Education Program (SBEP) are also eligible to participate in bidding process as well, however they will have to provide all information regarding their company afresh as prescribed below and fill in the technical criteria provided in the bidding documents. These companies will be re-evaluated for the purpose of this tender.

All the interested Bidders are required to submit a Letter of Intention to register their participation in Bidding for subject Tender along with copy of PEC Certificate and original paid chailan/receipt of non-refundable Tender Fee of Rs.2,000/- which is to be deposited in any branch of Sindh Bank Ltd on behalf of the Government of Sindh under head of account: "PD PM/U SBEP A/C No 0302-1653-111000 on or before 23rd November 2015.

All bids must be accompanied by a Bid Security in the amount of equivalent to 1.25% of quoted bid price in Pak Rupees or an equivalent amount in a freely convertible currency either in the form of Pay Order /Call Deposit/Demand Draft/ Bank Guarantee issued by any scheduled Bank of

Pacistan in favour of "Program Director, PMIU-Sindh Basic Education Program, Education & Literacy Department, Govt. of Sindh" and must be submitted along with sealed Bids. The Bids co npleted in all respects in accordance with clause IB-11 instructions to bidders of document are required to be printed, signed, stamped and submitted in hard copy (Complete Set in one Original & one Copy) along with required Bid Security as indicated above to PA office (addressed as above) on or before 30th November 2015 up to 1500 hours. The bids sent by mail/courier service should clearly mark the sealed envelope: "BID" and must be received to PA office before the mentioned timeline.

Bids will be opened at 1530 hours on the same day, in the presence of bidders' representatives who choose to attend at the same address. The bid validity period will be 90 days from the date of Bid Opening.

Bidders may obtain further information and/or clarification relevant to subject tender from the PA office during office hours in writing.

Pre-bid field visits to all the school sites in District Qambar Shahdadkot will be held on Tuesday 10th November 2015. The gathering point for the field visit will be Deputy Commissioner Office Qumbar at 0800 hours. All the expenses including travelling, lodging etc. shall be borne by the perticipating bidders on their own. Further details may be obtained from PA office.

A pre-bid meeting shall be held on 16th November 2015 at 1100 hours at PA office (address as above). The bidders may send their queries according to sub-clause: IB-8.1, Instructions to B dders.

All bids shall be evaluated on "Post-Qualification" method as per SPPRA Rules 2010 in accordance with the Evaluation Criteria and other terms and conditions set forth in the Bidding Documents. Hence, all the Bidders are required to submit the following information as per Evaluation Criteria provided in the bidding documents and submit along with their Bids:

- Name & Address etc. of the Contractor Firm (Complete contact details)
- 2. Nature of ownership (Company /Sole-Proprietorship/Partnership) with copy of Memorandum/ Article of Association/Partnership Deed.
- 3. Name, address and CNIC numbers of Directors/Partners of the firm.
- 4. Valid Registration Certificate from PEC as Constructor/Operator in relevant Category & Codes.
- 5. Income Tax Registration Certificate/NTN, Income Tax Returns (last three tax years) and copy of registration with SRB for GST (if applicable)
- 6. Financial Status of Company duly supported by audited reports of all accounts for past 3 years and current dated bank letter/s for credit facility offered by the concerned
- 7. Details of Projects of similar nature & complexity completed and in-hand.
- 8. Details of Staff including Technical, Administrative & support staff.
- 9. Details of Equipment/Tools/Plant including available construction equipment, machinery along with proof of ownership. (Location of machinery be given for verification)

Procuring agency reserves right to annul the bidding process and reject any or all bids/proposals only as per SPP Rules, 2010.
