**Objective and Scope:**

The Government of Sindh intends to apply for loans from the Asian Development Bank (ADB) for the SPRIP.

The Works and Services Department (WSD), Sindh, will be the Implementing Agency (IA) responsible for overall implementation of the Project. WSD is now seeking Expressions of Interest (EOIs) from suitable international firms in association with national firms to carry out the design review and construction supervision (Project Management Consultant PMC) of the civil works for Six contract packages as given below;

- b) Yearly turn over of the firm for last five years including Income Statement and Balance Sheet.
- c) General experience of the firm in the last five years or so and the list of ongoing projects in this respect including name of the Client and value of the assignment with man month inputs to be provided separately.
- d) Experience of the firm in similar geographic region (Asia) for the last five years or so including name of the Client and value of the assignment with man month inputs.
- e) Organization of the firm, List of permanent technical staff (both for lead and associate firm) with qualification, experience, address and proof that they are in the employment of the firm. The professionals assigned for this job are to be mentioned separately.
- f) Income tax status for the last 5 years.
