Bidding will be conducted under National Competitive bidding procedure specified in SPPRA rules 2010, (Amendment-2013) under single stage one envelope procedure.

The complete set of tender documents, specifications, drawings can be obtained from the office of the Project Director / Superintending Engineer Rohri Canal Circle Hyderabad on the payment of **Rs. 5000/- only (Non Refundable)**.

Tender should be sealed. The name of the bidder & tender description shall be clearly marked on all envelopes.

The Tender submitted by the intended contractors / firms must include following information.

1. Name of Firm along with permanent address, telephone numbers & e-mail address.
2. Bio-data of permanent technical staff along with Managerial and Organizational step.
3. List of work executed during the last 10 years along with estimated cost and name of client.
4. Detailed List of Work done of Concrete Lining in Canals, where sub soil water level was high and seepage from slopes & bed. **(during the annual closure period of 25 days)**.
5. List of Concrete Batching Plants, Lining Machines (to execute work 200 Feet width on bed and 35 Feet on Slope), Equipments, Transport and Machinery available with firm.
6. Copy of valid certificate of Pakistan Engineering Council in **Category C-A (No Limit)**.
7. Affidavit that the contractor has never been blacklisted by any agency.
8. Proof of financial capability including income tax return of last 03 years.

9. Credit line certificate from reputed bank.
10. Affidavit that the firm will complete the lining work within stipulated time.
11. Any additional information with supporting documents.
12. Registration with Sindh Revenue Board.

The bidders shall submit 2% Bid Security (earnest money) of the total Bid Amount with their bid in the shape of Call Deposit, Pay Order, Bank Draft or Demand Draft of any Scheduled Bank. Tenders without bid security will be rejected. In case of non-acceptance of bids, the bid security will be refunded after finalization of the tenders.


Bids are to be addressed and submitted to the office of the Project Director / Superintending Engineer Rohri Canal Circle Hyderabad opposite Hotel Faran, Saddar Hyderabad not later than ~~1200~~ **1200 hours** on ~~04~~ **04 January, 2016**.
