2. Single Stage –Two Envelopes procedure as per SINDH PPR-2010 Rule 46(2) will be followed (single sage two envelopes procedure) i.e. Technical and Financial Proposal will be placed in separate sealed envelopes and marked accordingly these two envelop should be placed in one envelop addressed to the Executive Director, JPMC, Karachi with Tender number and inserted in the Tender box on scheduled date and time.
3. The Technical Proposal must contain original data sheet technical brochure and all other relevant documents as mentioned in S.No.34.
4. In Financial Proposal the vendor should submit only rate of the equipment/items and a pay order of earnest money amounting 3% valve of quoted items in favor of Executive Director, JPMC, Karachi otherwise, the bid will be rejected.


