2. The tenders of the participating firms will be returned back on 12.30 P.M upto 16.02.2016 and will be opened on the same day at 1.00 P.M by the tender opening committee in presence of participating contractors firms or their authorized representatives of the firms who wish to be present.
3. Each bid shall comprises one single envelope containing the financial proposal and the required information as under.
 - h. List of works of similar nature and size for each completed in last 3/5 years, with documentary evidence along with satisfactory completion certificate of works from employer and details of ongoing works of similar nature with copies of letter of award of works.
 - i. Details of machinery and equipment available for execution of work with documentary evidence of ownership.
 - j. Qualification and experience of technical personnel and key site management.
 - k. Bank statement of last 3 years showing the credit limit.
 - l. Affidavit regarding not indulged in litigations and abandoned any works.
 - m. Affidavit that the firm is not black listed in past by any procurement agency.
 - n. Affidavit that the given information, documents and data is absolutely true and correct.
4. Tenders shall be carefully and neatly filed and signed by the bidders. Each bid must accompany the earnest money as mentioned against each works in shape of call deposit or demand draft / pay order of any schedule bank in favour of Project Director-I, Housing Project, H.D.A, bid security shall be submitted in the sealed envelope.
5. Financial statement (Summary) and Income Tax return for the last 3 years.
6. Registration with Income Tax department (NTN Copy) and Sindh Revenue Board (Sale Tax Registration) and copy of CNIC.
7. In case of undesirable circumstances on sub mission / opening date and time or if Government declares Holidays the tender shall be submitted / opened on the next working day at the same time and venue.
